1 WELCOME, INTRODUCTIONS AND APOLOGIES

4 HAYLE HARBOUR AUTHORITY OPERATIONS LTD – HARBOUR MASTER'S REPORT

The Harbour Master presented his report then took Questions

BM stated that the grant funding from the coastal community's fund was most welcomed and could only improve the estuary and the safety of its users. All those present agreed

RL asked if harbour users could access the CCTV. PM responded stating yes and that some users already have the APP.

JM asked if progress had been made with regard to the craning out of the John Martin. PM informed the meeting that Macsalvors have been on site to quote and stated that size of crane required for such a lift would be unable to access the quay because of the weight restriction

over the St Erth to St Ives line, railway bridge which is 40 Tons. JM suggested two smaller cranes may be able to lift the vessel. PH to investigate

5 Carnsew Pool

Rob Lello chair of the Carnsew working group gave a brief summary to those present explaining the aims of the working group and David Tugwell operations director had met with both the RSPB and Jeremy content from Cornwall Council with regard to the funding required to affect the repairs required to stabilise the coastal footpath.

The RSPB have stated that they will not fund the project as they do not consider that the erosion to the footpath is of their making.

To date a response is still awaited from Cornwall Council.
