



## Schedule of Harbour Dues and Charges 2021/22

Under the Harbours Act 1964 & The Hayle Harbour Act 1989

ALL VESSELS ENTERING THE JURISDICTION OF THE HARBOUR MUST PAY DUES AS SET OUT BELOW  
ALL PRICES INCLUDE VAT AT 20%

### 1. Mooring Licence

All vessels £35 includes admin fee.

### 2. Harbour dues

#### 2.1. Pleasure vessels

Penpol Bank & Lelant Saltings	£52.50/metre
Quay Walls (minimum 6m)	£52.50/metre
East Quay Pontoons (minimum 6m)	£73.50/metre

#### 2.2. Commercial vessels

Penpol Bank & Lelant Saltings	£73.50/metre
Quay Walls (minimum 6m)	£73.50/metre
East Quay Pontoons (minimum 6m)	£73.50/metre

#### 2.3. Visiting Pleasure vessels (max stay 30days)

Price per night Quay Wall Berth	£2/metre
Price per night East Quay Pontoon Berth (subject to availability)	£2.50/metre

#### 2.4. Visiting Commercial Vessels (max stay 30days)

1-6 Days	£3/metre per day
7-20 Days	£2.50/metre per day
21+ Days	£2/metre per day

#### 2.5. Dues for sheltering local vessels by arrangement with the Harbour Master

All sheltering vessels should give at least 1 days notice to the Harbour Office. Vessels over 20m OAL must give 7days notice before entering the harbour.

#### 2.6. Vessels in Distress, towed in by the RNLI

No charge for 7days

### 3. Slipway (please see slipway T&Cs for more information)

Registration fee. (required before any launch can take place)	£10
Day Pass including parking for vehicle and trailer	£15
Weekly Pass including parking for vehicle and trailer	£60
12month Pass including parking for vehicle and trailer (includes registration)	£156
PWC Pass 12months including PWC registration	£156



**4. Dry Berthing**

£9/m PCM.

All dry berthing will be under Licence, to be signed before berthing commences. Location will be allocated by the Harbour Master.

**5. Car Parking**

Mooring Holders £42

Non-mooring holders -Limited numbers at the digression of the Harbour Master

**6. Mooring Application**

A non-returnable charge of £20 will be payable upon completion of a Mooring Application form. This does not guarantee you a mooring allocation.

**7. Crane Operations**

Crane Operations £20 per lift on Harbour Land.

All cranaage to be approved by the harbour office a minimum of 1 working day before cranaage can take place.

**8. Call Out Charges**

Harbour Staff call outs for non-emergencies. Will be charged at £30/hour per staff member.

All harbour dues are charged at LOA and run from 1<sup>st</sup> April until 31<sup>st</sup> March no part-payment possible or refunds.

Subletting of moorings will not be permitted under any circumstances. All vessels in Hayle Harbour must have a current valid signed mooring licence.

Vessels undergoing works by A Baumbach that are on harbour land or moorings will be subject to Harbour dues and charges as per the schedule of rates

It is the responsibility of the owner or skipper of any vessel brought within the jurisdiction of Hayle Harbour to pay appropriate harbour dues.

Harbour dues will be charged at the daily rate for every day a vessel is in the harbour, unless arrangements are made with the Harbour Office to pay on an annual, monthly or weekly

Failure to pay Harbour dues may result in vessels being impounded until all outstanding dues have been paid.

Hayle Harbour Act Part IV Paragraph 43 states "If the owner of any vessel shall at any time evade, or attempt to evade, payment of any charges payable by such owner to the Company at the time when the same shall become due and payable, he shall be liable to pay to the Company a sum of £20 or a sum equal to three times the amount of such charges (whichever shall be the greater), which sum shall be a debt due to the Company."
